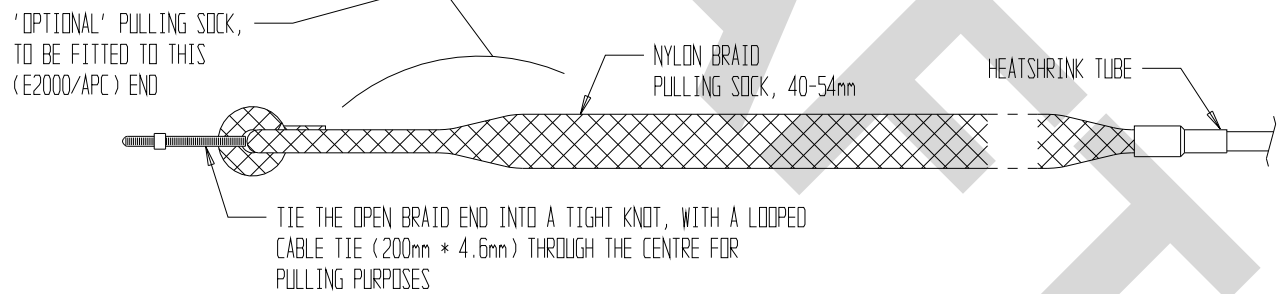
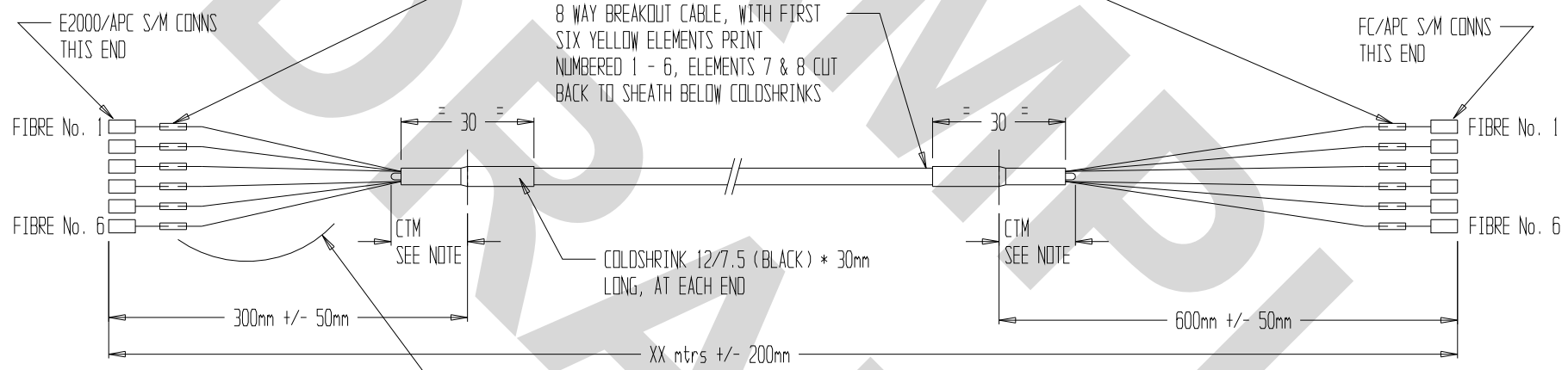

- ALL THE RUGGEDISED ELEMENTS ARE TO BE CORRECTLY NUMBERED AS PER CONVENTIONAL CABLE MARKINGS.
- THIN WALL COLDSHRINK TUBE IS FOR COSMETIC PURPOSES, AND MUST BE FITTED IN A MANNER WHICH AVOIDS DAMAGE TO THE FIBRES/RUGGEDISED ELEMENTS.
- CONNECTORS TO BE FITTED TO AGREED TECHNICAL CRITERIA.
- ALL ELEMENTS TO BREAKOUT FROM THE CABLE TO AN EQUAL LENGTH AS PER END DIMENSION.
